

# 2017 4-H/FFA Rebate Program

*Hood River Supply is proud to support the efforts of 4-H and FFA members with a Rebate Program for Feed and Supply Purchases*



1. Participants must be 4H or FFA members. Participants must be residents of Hood River, Wasco, Skamania or Klickitat Counties.
2. Program is for breeding and market cattle, hogs, lambs, goats, rabbits, and poultry. Two (2) animals per participant are allowed to be in the program. Number of animals in each specie must be determined at the beginning of the sign up period. After the sign up deadline you may not add animals.
3. The sign up period for the program begins November 1, 2016 for Cattle and March 1, 2017 for hogs, lambs, goats, rabbits and poultry. Final signup date is June 1, 2017, for all animals. **NO EXCEPTIONS!!!** Participants must sign up in the Hood River retail store. One copy of the completed application will be kept on file at the Hood River store office. 4-H/FFA members must keep a copy of the application for their records and submit it for awards if they are Grand or Reserve Grand Champion winners.
4. Each participant must be on file prior to making purchases for the Rebate Program. (*Feed purchased on a parent's account is not eligible for the program.*)
5. 4-H/FFA participants are responsible for telling the retail store employees that they are participating in the Rebate Program and the feed that they are purchasing needs to be added to their account. **Save your receipts for your records!** Any and all account balances must be paid in full each month. (Parents must submit request for accounts to have charge privileges.)
6. Rebate program ends after the Oregon State Fair.
7. Rebate checks will be mailed by October 31, 2017.
8. Minimum feed purchases per animal to be eligible for rebate participation are as follows: Goats - four (4) 50lb bags; Sheep - six (6) 50lb bags; Hogs - eight (8) 50lb bags; Cattle - thirty (30) 50lb bags; Poultry - one (1) 50lb bag or equivalent; Rabbits - one (1) 50lb bag or equivalent.
9. Maximum feed purchases per animal for rebate are as follows: Goats - ten (10) 50lb bags; Sheep - twelve (12) 50lb bags; Hogs - eighteen (18) 50lb bags; Cattle - sixty (60) 50lb bags; Poultry - two (2) 50lb bag or equivalent; Rabbits - two (2) 50lb bag or equivalent. **Rebate checks under \$5 will not be issued.**
10. 4-H or FFA exhibitors winning Overall Grand Champion or Reserve Grand Champion breeding or market livestock at the County Fairs are eligible for additional rebates. Only one county fair event will qualify for awards. Jackpot and prospect shows do not qualify.
11. If you win Grand or Reserve Grand Champion, submit this completed form by October 15<sup>th</sup>, to the store in Hood River, Oregon. *Forms submitted after October 15<sup>th</sup> will not be processed.*
12. Winners, please submit a full color photo of yourself with your winning animal. If a professional photographer is present at the show, please include the photographer's name, phone number, address and image number on the back of the form.
13. Hood River Supply Assn reserves the right to interpret the rules of this program. Program is subject to change or cancellation each year. The Rebate Program cannot be combined with other offers including frequent feeder cards or other discounts.



## Rebate Program:

- **At the end of the program year, all qualifying participants will receive a rebate equal to 10% of qualifying feed purchases and 5% of qualifying fencing, animal health and show products.**
- **Qualifying Overall Grand Champion participants will receive a rebate equal to an additional 10% of qualifying feed purchases.**
- **Qualifying Reserve Grand Champion participants will receive a rebate equal to an additional 5% of qualifying feed purchases.**
